- i. content or materials in which Entrant impersonates another person or entity
- j. content that depicts alcohol or tobacco
- k. content disparaging any other person or party affiliated with the Contest or the administration of the Contest.

WINNER SELECTION AND NOTIFICATION: 12 winners will be selected in a random drawing at the end of each month from eligible entries received during that month's Submission Period by Sponsor or its designated representatives, whose decisions are final. Winner(s) will be notified by email and their first name and last initial will also be announced on the associated social media platform in which they initially entered.
